

## 1. Terms and Conditions

(iii) agree to the conditions of entry set by the venue at which Business & Beyond will take place, being Brisbane Convention & Exhibition Centre, Glenelg St, South Brisbane QLD 4101 Australia

(iv) acknowledge and understand it is incumbent upon you to provide SRA with full and accurate details of each attendee as required under section 4, failing which you may not receive the benefits to which you may otherwise be entitled.

(v) agree that whilst the advertised line up & agenda is correct at release, it is subject to change without notice and that you will have no claim against SRA either for a refund or for any other claim whatsoever.

(ii) until payment has been completed in full, you will not be entitled (nor able) to receive any of the inclusions associated with your purchase of Business & Beyond.

(b) All pricing is in Australian Dollars and includes local taxes.

## 4. Requirements of Purchase

(a) A name, contact number & unique email address will be required for the purchase of Business & Beyond.

(b) All tickets purchased for Business & Beyond will be sent to the buyer who will then be responsible for forwarding the tickets to their guests/attendees.

(c) When entering the venue photo identification may be requested & must match the name on the ticket to guarantee entry.

## 5. Cancellation Rights

(a) Note that there is no cooling-off period and payment for a Transaction is not refundable.

(b) If Business & Beyond is postponed for any reason, your inclusions will apply to the rescheduled event. A rescheduled event will be provided to you before 21<sup>st</sup> of June 2025.

- (c) If Business & Beyond is cancelled for any reason, you will be entitled to a refund of the Business & Beyond purchase but will have no other claim of any nature arising out of such cancellation.
- (d) Inclusions not used are not able to be swapped or exchanged for credit.
- (e) If you purchase Business & Beyond by speaking to an SRA team member via telephone, you will have 10 business days from the date of purchase to cancel your purchase & obtain a full refund. Requests must be made in writing to [info.au@srglobal.com](mailto:info.au@srglobal.com) for a refund to be considered.
- (f) Should you qualify for a refund, the amount will be refunded within 30 business days from cancellation.

## **6. Business & Beyond Resale**

- (a) The re-advertisement or re-sale of Business & Beyond inclusions is strictly forbidden.
  - (b) If any inclusions of Business & Beyond are found to be re-advertised or for re-sale SRA reserves the right to cancel all inclusions with no refund provided.
  - (c) Only purchases made directly through SRA for Business & Beyond will be guaranteed access to the inclusions listed in section 3.
- Scalping warning: The resale of inclusions in certain circumstances is governed by ticket sales legislation and may attract criminal penalties.

## **7. Force Majeure**

- (a) If Business & Beyond has to be re-scheduled, postponed or cancelled as a result of an act of God, Government legislation, public health orders, an inevitable accident, power cut, fire, blackout, flood, COVID-19, pandemic, injury, death or any other calamity, or if by reason of strikes, or lockouts, or any other events beyond the direct control of either party, SRA reserves the right to postpone and reschedule Business & Beyond and the provisions of section 5(b) or 5(c), as the case may be, will apply.
- (b) SRA reserves the right to alter the venue, speakers and amend the agenda due to circumstances outside of its control-
- (c) SRA will not be liable in any manner whatsoever for any cancellation or postponement of the Business & Beyond because of Force Majeure or a change of venue or amendment to the agenda arising out of this clause 7.

## **8. Privacy and your security:**

- (a) SRA will collect personal information including but not limited to name, contact details, email address and postal address. This information will only be shared with approved partners to provide access to Business & Beyond and enhance your Business & Beyond experience.
- (b) You acknowledge and agree that SRA may disclose and use your personal information in accordance with the SRA privacy policy available at <https://success-resources.com.au/privacy-policy.html>
- (c) Should you not wish to appear in any promotional or marketing materials you must notify us via [info.au@srglobal.com](mailto:info.au@srglobal.com) at least 14 days before the date of Business & Beyond.

## **9. Filming:**

- (a) You acknowledge and agree that portions of Business & Beyond may be recorded, and that SRA shall own any recordings that can be used at their discretion for promotional or marketing purposes.
- (b) You agree not to record any part of Business & Beyond. Failure to comply with this directive could lead to your participation in Business & Beyond being revoked with no refund or credit being provided.
- (c) You may not use recordings from Business & Beyond for commercial purposes without the prior written consent of SRA which may be withheld in our absolute discretion.
- (d) Without derogating from the above, materials distributed by SRA as part of Business & Beyond may not be distributed or re-produced.
