

## TERMS AND CONDITIONS

### 1. Agreement

(a) You are entering into a transaction (the **Transaction**) with Success Resources Australia PTY LTD (herein after referred to as 'SRA') to purchase a package known as 'Money Mentor Masterclass' (herein after referred to as 'MMC'), presented by Infinity Group Australia (herein after referred to as 'IGA' by Graeme Holm, entitling you to the inclusions set out in section 3 below.

(b) By proceeding with the Transaction and making a payment, you confirm that you:

(i) have read, understood, and agree to these terms and conditions.

(iii) agree that your information will be shared with the training provider IGA.

(iv) acknowledge and understand it is incumbent upon you to provide SRA with your full and accurate details failing which you may not receive the benefits to which you may otherwise be entitled.
